NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Growth Through Learning, Inc. (GTL) was founded and incorporated as a nonprofit, 501(c)(3) organization in July 1997. GTL's mission is to support education and development by providing full scholarships to secondary schools for bright young women in Kenya, Tanzania, and Uganda who would otherwise be unable to afford an education.

Basis of Accounting

The financial statements of GTL have been prepared on the accrual basis of accounting and accordingly, reflect all significant receivables, payables, and other liabilities.

Net Assets

Net assets, revenues, gains, and losses are classified based on the existence or absence of donor- or grantor-imposed restrictions. Accordingly, net assets and changes therein are classified and reported as follows:

Net Assets Without Donor Restrictions – Net assets that are not subject to donor-imposed stipulations and available for use in general operations.

Net Assets With Donor Restrictions – Net assets that are subject to donor-imposed stipulations. Some donor-imposed restrictions are temporary in nature, such as those that will be met by passage of time or other events specified by the donor. Other donor-imposed restrictions may be perpetual in nature, where the donor stipulates that resources be maintained in perpetuity. There were no net assets held in perpetuity as of June 30, 2021.

During 2020, net assets of \$5,000 were released from net assets with donor restrictions as GTL satisfied the purpose restrictions. As of June 30, 2021, the Organization had net assets restricted by donors for time and purpose amounting to \$180,000.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates, and those differences could be material.

Subsequent Events

Subsequent events have been evaluated through September 10, 2021, the date the financial statements were available to be issued.

Cash and Cash Equivalents

GTL considers all cash and highly liquid financial instruments with original maturities of three months or less, which are neither held for nor restricted by donors for long-term purposes, to be cash and cash equivalents.

Certificates of Deposit

Certificates of deposit are stated at original cost basis plus accrued earnings. All Certificates are held at FDIC-Insured financial institutions and are expected to mature within a year of the financial statement date.

Property and Equipment

Property and equipment are stated at cost if acquired, or fair value, if donated. The costs of additions and betterments in excess of \$500 and a useful life greater than one year are capitalized at the discretion of management when deemed appropriate and expenditures for repairs and maintenance are expensed when incurred. Depreciation is computed using the straight-line method over useful estimated lives as follows:

Depreciation for the years ended June 30, 2021 and 2020 was \$300 in each year.

Revenue Recognition

Contributions are recorded as receivables and revenues, and the Organization distinguishes between contributions received for each net asset category in accordance with donor-imposed restrictions. Contributions may include gifts of cash, real property, or promises to give. Contributions, including unconditional promises to give, are recognized as revenues in the period received. Conditional promises to give are not recognized until they become unconditional, that is, at the time when the conditions on which they depend are substantially met. Contributions to be received after one year are discounted at an appropriate discount rate commensurate with the risk involved, when such amounts are considered material. Multi-year commitments are recognized during the year of the initial pledge.

Support that is restricted by the donor is reported as an increase in net assets with donor restrictions depending on the nature of the restriction until the restriction expires, at which time net assets with restrictions are reclassified to net assets without donor restrictions. If a restriction is fulfilled in the same time period in which the contribution is received, GTL reports the support as without donor restrictions.

Contributions Receivable

Contributions receivable are stated at the amount management expects to collect from outstanding balances. Management evaluates the balances in accounts receivable and would provide for probable uncollectible amounts through a provision for bad debt expense and an adjustment to a valuation allowance based on its assessment of the current status of individual accounts. There were no contributions receivable as of June 30, 2021 or June 30, 2020.

Donated Goods and Services

Donated goods and other noncash donations are recorded as contributions at their estimated fair value at the date of donation. Donated services are recognized as contributions in accordance with professional standards if the services (a) create or enhance nonfinancial assets or (b) require specialized skills, are performed by people with those skills, and would otherwise be purchased by the organization. There were no contributed goods or services during the years ended June 30, 2021 or 2020.

Operating Lease

GTL currently leases office space in Cambridge, Massachusetts as a tenant-at-will on a month-to-month basis from an unrelated entity. Total monthly expense approximates \$250. Rent expense was \$3,000 for the year ended June 30, 2021 and \$3,600 for the year ended June 30, 2020.

Advertising

GTL expenses advertising as incurred. Advertising expenses were \$149 and \$133 for the years ended June 30, 2021 and 2020, respectively.

Tax Exempt Status

GTL is a nonprofit corporation that is exempt from income taxes under Internal Revenue Code Section 501(c)(3) and, as a corporation organized under Chapter 180 of the Massachusetts General Laws, it is also exempt from Massachusetts income tax. Accordingly, no provisions for federal and state income taxes are made in these financial statements.

Functional Allocation of Expenses

The cost of providing the program and supporting are summarized on a functional basis. Expenses that can be identified specific to the program or supporting service are allocated directly. Expenses that are not direct to a program or supporting service are allocated based on management's estimate of where employees spend time in providing program or supporting services. During the year ended June 30, 2021, salaries and related benefits and payroll taxes were allocated based on estimated time in each function. All other expenses were directly allocated to their respective function.

Reclassifications

Certain reclassifications of amounts previously reported have been made to the accompanying financial statements to maintain consistency between periods presented. The reclassifications had no impact on previously reported net assets

NOTE 2 CONCENTRATION OF CREDIT RISK

GTL maintains its cash deposits and certificates of deposit at local financial institutions insured by the Federal Deposit Insurance Corporation (FDIC). Deposits at FDIC insured institutions are insured up to at least \$250,000 per depositor. At June 30, 2020, there were no uninsured balances.

For the year ended June 30, 2021, approximately 50% of contribution revenue was from one donor. The contribution was received in full as of June 30, 2021.

NOTE 3 AVAILABLE RESOURCES AND LIQUIDITY

GTL regularly monitors liquidity required to meet its operating needs and other contractual commitments. For the purpose of analyzing resources available to meet general expenditures over a 12-month period, GTL considers all expenditures related to its ongoing activities to be general expenditures. In addition to financial assets available to meet general expenditures over the next 12 months, GTL anticipates collecting sufficient revenue to cover general expenditures.

As of June 30, 2021, GTL's financial assets available include cash of \$404,965 and certificates of deposit maturing within 12 months amounting to \$304,757. Included in this amount is \$180,000 with donor restrictions. As of June 30, 2020, GTL's financial assets available included cash of \$182,871 and certificates of deposit maturing within 12 months amounting to \$209,434. These assets are not subject to donor or other contractual restrictions that make them unavailable for general expenditure within one year of the balance sheet date.

NOTE 4 MAINE COMMUNITY FOUNDATION FUND

In 2005, the Maine Community Foundation (the Foundation) informed GTL that the Foundation received an anonymous grant of \$950,000 that the Foundation classified as a designated fund for GTL for the purpose of providing future stability to GTL. The spending from the fund is limited to investment income only, subject to approval from the Foundation. Annually, GTL submits a written request to the vice president for philanthropic services at the Foundation, who approves the annual grant from the fund. The income earned from the fund was originally restricted to support the cost of an executive director at GTL. In 2007, the Foundation authorized the use of the distributions from the fund to also include nonpersonnel related operating expenses, to the degree that the distribution is in excess of the executive director's salary costs. This use of the funds may be submitted in writing for approval, which would describe the deviations from the primary purpose. If GTL determines the investment income of the fund is not needed in any given year, the income for that year is reinvested into the principal.

NOTE 5 LOAN PAYABLE

In May 2020, the Organization received a loan from in the amount of \$15,625 to fund payroll costs through the SBA's Paycheck Protection Program (the PPP Loan). The original loan agreement was written prior to the PPP Flexibility Act of 2020 (June 5) and was due over 24 months deferred for six months. Subsequent to this, the law changed the loan deferral terms retroactively. The PPP Flexibility Act and subsequent regulations superseded the loan agreement. The PPP Loan had a stated interest rate fixed at 1.0% per annum, a term of two years, and was unsecured and guaranteed by the U.S. Small Business Administration. Payment of principal and interest was deferred until the date on which the amount of forgiveness is remitted to the lender or, if the Organization failed to apply for forgiveness within 10 months after the covered period, then payment of principal and interest shall begin on that date. GTL was legally released from the debt and the loan forgiveness has been recorded as income for the year ended June 30, 2021. The SBA may review funding eligibility and usage of funds in compliance with the program based on dollar thresholds and other factors. The amount of liability, if any, from potential noncompliance cannot be determined with certainty; however, management is of the opinion that any review will not have a material adverse impact on the Organization's financial position.

In February 2021, GTL received a Second Draw PPP Loan of \$15,625 as part of the Paycheck Protection Program. These funds must be used in accordance with the program requirements. Additionally, some or all of the funds may be forgiven based on compliance with program requirements and approval by the U.S. Small Business Administration. GTL expects to apply for forgiveness in fiscal year 2022 and, therefore, has included the loan as a current liability as of June 30, 2021.
